15 Description of Product

The Type 33MK2A Half Coupler for use at 3300V, 500A (maximum) comprises a compound filled sealing box, made of cast gunmetal, fitted with a cable gland assembly for single sire armoured cable. Access for filling with the compound is via two Group I stopper plugs. The half coupler incorporates an insulator assembly with three main contact tubes and up to six pilot connectors which are crimped to the cable conductors.
